MAHARASHTRA ACT No. I OF 2023.

(First published, after having received the assent of the Governor in the "Maharashtra Government Gazette", on the 3rd January 2023).

An Act further to amend the Mumbai Municipal Corporation Act.

WHEREAS both Houses of the State Legislature were not in session ;

AND WHEREAS the Governor of Maharashtra was satisfied that circumstances existed which rendered it necessary for him to take immediate III of action further to amend the Mumbai Municipal Corporation Act, for the 1888. purposes hereinafter appearing ; and, therefore, promulgated the Mumbai Mah. Municipal Corporation (Second Amendment) Ordinance, 2022 on the 24th Ord. November 2022;

> AND WHEREAS it is expedient to replace the said Ordinance, by an Act of the State Legislature; it is hereby enacted in the Seventy-third Year

(1) This Act may be called the Mumbai Municipal Corporation Short title 1. and (Second Amendment) Act, 2022. commencement. महाराष्ट्र शासन राजपत्र असाधारण भाग आठ, जानेवारी ३, २०२३/पौष १३, शके १९४४

(2) It shall be deemed to have come into force on the 24th November 2022.

Amendment **2.** In section 154 of the Mumbai Municipal Corporation Act (hereinafter III of 1888. 111 of 1888. referred to as "the principal Act"), in sub-section (1D), in clause (a),—

(i) in sub-clause (i), for the words and figures "and the year 2021-22" the words and figures ", the year 2021-22 and the year 2022-23" shall be substituted ;

(ii) in sub-clause (ii), for the words and figures "and the year 2021-22" the words and figures ", the year 2021-22 and the year 2022-23" shall be substituted ;

(iii) in sub-clause (iii),—

(a) for the words and figures "in the year 2022-23" the words and figures " in the year 2023-24" shall be substituted ;

(b) for the words and figures "and the year 2021-22" the words and figures ", the year 2021-22 and the year 2022-23" shall be substituted.

Power to remove difficulty. Bower to an ended by this Act, the State Government may, as occasion arises, by an order published in the *Official Gazette*, give such directions, not inconsistent with the provisions of the principal Act, as amended by this Act, as may appear to it to be necessary or expedient for the purposes of removing the difficulty :

Provided that, no such order shall be made after the expiry of a period [.] of two years from the date of commencement of this Act.

(2) Every order issued under sub-section (1) shall be laid, as soon as may be, after it is issued, before each House of the State Legislature.

Repeal of Mah. Ord. XII of 2022 and Ordinance, 2022, is, hereby repealed. saving. 4. (1) The Mumbai Municipal Corporation (Second Amendment) Mah. Ord. XII of 2022.

> (2) Notwithstanding such repeal, anything done or any action taken (including any notification or order issued) under the corresponding provisions of the principal Act, as amended by the said Ordinance, shall be deemed to have been done, taken or, as the case may be, issued under the corresponding provisions of the principal Act, as amended by this Act.
