CHANGES IN DP57 AND DP89 REPORT

DPs are advised to refer CDSL Communiqué Nos. CDSL/OPS/DP/SETTL/2022/660 dated November 11, 2022, regarding Block Mechanism in Demat account of clients undertaking Sale Transactions.

Based on feedback received from DPs / Members CDSL is pleased to inform that w.e.f., January 27, 2023, EOD Overdue Early Pay-in (EP) transactions will be reported in DP57 (Common Download Report) and DP89 (Probable Shortage Report) report.

DPs are advised to note the following changes in DP57 and DP89 report:

- DP57 Report Quantity debited at the time of Pay-in for overdue EP transactions will be reported in column "Earmark Quantity" of DP57 report for EP. Scheduled for release on January 20, 2023.
- DP89 Report Currently EP transactions with overdue status are not considered for calculating shortage quantity. With the introduction of EP transaction with overdue status, calculation of shortage quantity will also include available balance of overdue EP transaction. Scheduled for release on January 27, 2023. The changes in DP89 report are as follows:
 - o New Transaction Status as "O" is introduced for Overdue EP transactions.

DPs are hereby informed that there is no change in file format only new values have been introduced in the existing fields (refer Annexure A).

DPs are advised to take note of the same and incorporate necessary changes in their backoffice software, if any.
