## ORDERS BY THE GOVERNOR OF ASSAM NOTIFICATION

**No. E-194696/50**: Whereas the "Vehicle Scrappage Policy of Assam, 2022" was notified vide notification No. TMV.72/2022/39, dated 18th July, 2022 with a provision to launch a "One Time Settlement" scheme to incentivize voluntary scrappage of old and unfit vehicles;

Now, therefore, in pursuance of the "Vehicle Scrappage Policy of Assam, 2022" and in exercise of the power's conferred on the State Government by Section 3 of the Assam Motor Vehicle Taxation Act 1936 and Section 65(2)(h) of the Motor Vehicle Act 1988, the Governor of Assam is pleased to notify a One Time Settlement (OTS) scheme.

As per the Scheme, on voluntary offer of a vehicle to a Registered Vehicle Scrapping Facility (RVSF) for scrapping, 75% of the total outstanding arrear dues/liabilities (MV tax, fitness fine etc.) against the vehicle shall be waived off.

The one time settlement scheme shall be effective for a period of 1 (one) year w.e.f. 15<sup>th</sup> January 2023.
