GOVT. OF NCT DELHI - DELHI PRIVATE SECURITY AGENCIES (REGULATION) RULES, 2023

Attention all private security agencies operating in Delhi! The Government of the National Capital Territory of Delhi has recently notified the Delhi Private Security Agencies (Regulation) Rules, 2023, implementing significant changes for your operations. Stay informed with this comprehensive newsletter:

What's New:

- **Enhanced Registration Process:** The rules prescribe a more stringent and detailed registration process for private security agencies, including stricter qualification criteria, mandatory training for security guards, and increased documentation requirements.
- **Licensing & Renewal:** The existing licensing system will be revamped, introducing new fees and requiring regular renewals with stringent compliance checks.
- **Stricter Monitoring & Enforcement:** The DIL will have enhanced powers to inspect premises, audit records, and impose penalties for non-compliance.
- **Improved Standards & Service Quality:** The regulations aim to elevate the professionalism and service quality of private security agencies in Delhi, ensuring better training, equipment, and conduct of security personnel.

Few Compliances :

1. Make an application in Form I to the Controlling Authority for the grant of license also enclose the Form II for verification of his antecedents.
2. Apply for renewal of the license in Form I along with Form II and Form III within forty-five days before the date of expiry of the license

This Act has superseded the Delhi Private Security Agencies (Regulation) Rules, 2009.
