- *This is relevant especially for those preparing for recognition from NABL to demonstrate competence and quality in medical testing.*

What is the alteration?

- NABL has introduced a Medical Application Portal for ISO 15189:2022 accreditation.
- It was launched at the “GOING LIVE” virtual event on 19 August 2025.
- This substitutes the previous, paper-intensive system with a completely digital procedure.

What has been enhanced?

- Sequential process flow for laboratories to avoid overlooking important specifics.
- Templates and a pre-registration checklist to minimize mistakes.
- User-friendly interfaces that make it easy for newcomers to navigate.
- Multi-user access, labs can designate roles to various staff for quicker task completion.

What's the importance?

- The previous method frequently extended over weeks or even months because of documentation and coordination challenges.
- According to QCI Chairperson Shri Jaxay Shah, the same task can now be completed in only 2–3 hours with the new system.
- This results in faster accreditation and reduced administrative workload for laboratories.

Openness & Responsibility

- NABL Chairperson Dr. Sandip Shah described the update as transformative.
- Functions such as multi-user accessibility, organized workflows, and electronic monitoring guarantee complete transparency.
